WHEREAS, Tarkeshwar Narayan Agrawal Teacher's Training College, Vill – Harigaon, Po – Sanya Barhatta, Jagdishpur, City – Ara, Dist – Bhojpur, Bihar – 802301 (Code No. APE01012) had applied for grant of recognition for B.Ed. Course of one year duration under Section 14 of the NCTE Act, 1993 to the ERC, NCTE on 24.10.2008.


3. AND WHEREAS upon consideration of the written representation submitted by the institution as well as documents and materials submitted by the institution along with application the Eastern Regional Committee in its 95th meeting held on 27th-29th April 2009, came to the conclusion that recognition to the said institution be refused for the following reasons:


- (i) The institution submitted certified copy of land document which is registered on 08.04.2009 i.e. after the last date of submission of application which is not as per Norms.
- (ii) The institution submitted plan which appears to a Line plan.
- (iii) Plot No. given in the land document, Building completion certificate, Building plan & affidavit do not tally.
- (iv) As per the application form built up area is less than the required.
- (v) Letter No. GC-07/09 dtd. 09.04.09 is permission of competent authority reg. running the educational institution but it does not appear as a permission reg. educational institution.

4. AND WHEREAS the institution preferred an Appeal to the Appellate Authority, NCTE-HQrs and the Appellate Authority vide order No. 89-447/2009-Appeal / A211 dated 11.09.2009 had remanded back the case to ERC-NCTE for causing inspection of the institution.

5. And whereas as per the directions of the Appellate Authority, the Visiting Team was deputed to the institution and the visiting team visited the institute on dt.09.12.2009.

3. AND WHEREAS upon consideration of the written representation submitted by the institution as well as documents and materials submitted by the institution along with application the Eastern Regional Committee in its


109th meeting held on 21st – 23rd June, 2010, came to the conclusion that recognition to the said institution be refused for the following reasons:

- (i) Principal not qualified as per NCTE norms.
- (ii) The land documents have been registered in the name of institution on 8th April 2009 wherein the mention of building on the land is not there. Even in the Gift deed it is clearly mentioned that the said land is a Residential Parti.
- (iii) The Certificate of Approved building issued on 25th Dec 2008, Completion Certificate issued by Sarpanch on 15th October 2008, Building completion certificate issued on 9th April 2009 clearly shows that the building was constructed on the date the land was gifted to the institution. In the Gift Deed executed on 9th April 2009, there is no mention of the building already constructed on the said plot, whereas as per the Building Completion Certificate the building was constructed prior to the execution of the Gift Deed.
- (iv) The Gift Deed clearly states that the land which is being gifted is a Residential Parti and the institution had not submitted the Change of Land Use Certificate issued by the competent authority.
- (v) The institution has not submitted the Non-Encumbrance Certificate issued by the competent authority.
- (vi) With regard to Notice pointed out by ERC, the institution had appointed another Principal by a duly constituted Committee.
- (vii) The institution has appointed the staff as per Regulations 2007 whereas the same has to be appointed after issue of 7(9) and the same shall be as per Regulations 2009.

9. AND WHEREAS the institution preferred an Appeal to the Appellate Authority, NCTE-HQrs against the said order of ERC and the Appellate Authority vide order No. No. 89-954/2010-Appeal/A25969 dated 27.09.2010 had reversed the ERC's order dated 29-06-2010 with direction to ERC to grant formal recognition to the institution immediately.

13. The original file along with other documents, the order of the appellate authority, NCTE Act, Rules, Regulation and norms and Standards were placed before the Committee in 113th ERC meeting and the Committee decided that as per the orders of appellate authority, order of formal recognition under clause 7 (11) of NCTE Regulations 2009 be issued.

14. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee grant of recognition to **Tarkeshwar Narayan Agrawal Teacher's Training College, Vill – Harigaon, Po – Sanya Barhatta, Jagdishpur, City – Ara, Dist – Bhojpur, Bihar – 802301**; for conducting **B.Ed. Course of one year duration with an annual intake of 100 students** from the academic session 2010-2011 under clause

7(11) of NCTE (Recognition Norms & Procedure) Regulation 2009 subject to fulfillment of the following:

- (i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cutoff date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012 only.
- (ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 200 teaching days the session is fulfilled as per the calendar of the University/Affiliating Body.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Eastern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (vi) The institution shall ensure that the required number of academic staff for conducting the course is always in position.


15. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

16. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

17. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

18. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued

there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

19. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
